## Conditions for Entry:

- ☆ Entry for nominations is open to all Government entities in India (Centre, State and Union Territory).
- ☆ All the Government Organizations & Semi-Government Corporations, District Collectorate, Municipal Corporations, Autonomous bodies including Public Sector Undertakings are welcome to apply
- ☆ Entries should be submitted against one of the specified Award categories.
- ☆ In case of project category, at least 75% of the services being delivered should be Government services.
- ☆ Awards for year 2010-11 will consider the value additions and contributions made during 1st Apr 2010 to 31st March 2011. These can be either implemented during the current year in question, or special incremental efforts or enhancements to the earlier initiatives.
- ☆ To encourage fresh e-Governance Initiatives, nomination of those cases that were already awarded during the previous two years of CSI-Nihilent eGov award process, will not be considered for this year's awards.

## Judging Process

- ☆ Nomination to each category will be judged by the Awards Selection Committee, consisting of members from Government, Industry and Academia
- ☆ The judging process shall be based on information submitted on-line, through nomination submission templates.
- ☆ Following the on line submissions, a first level short-list will be drawn up after scrutiny of information/ documents submitted for scheduling field visits.
- ☆ The Field visits to sites may be made by member's/ nominated member's of the Selection Committee for on the field assessment. The selection committee may in some cases, engage in interactions on phone/email instead of field visits.
- ☆ After the completion of the field visits and based on overall scores compiled through AHP process 'Finalists' will be identified.
- ☆ These 'Finalists' will be invited for a presentation to the selection committee.
- ☆ Based on the information provided in the nomination template, field visits report and after the presentations by the 'Finalists', winners will be identified for all the Categories.
- ☆ The Selection Committee reserves the right to seek additional information from the nominated entries during the evaluation process.

## Evaluation Criteria for the Awards

- ☆ The evaluation criterion is based on two indicators i.e. Results and Enablers. The attributes considered for Result indicator are mainly in terms of outcome and the attributes for Enabler indicator are in terms of the processes in place so as to achieve the desired results. Keeping into consideration the constraints on time and resource, for the purpose of these Awards, only the key attributes are being considered for these awards.
- ☆ The quality of content submitted by the applicants for the nominations will be of most important part of the evaluation process. The information should be as per format and restricted to the prescribed page length defined in the respective "Nomination Submission Template" as given on the website indicated above. The information provided in the nomination form should contain the crucial and important aspects only.
- ☆ The key indicators and attributes being used for evaluation under each award category are given in subsequent pages in the Nomination submission Template as mentioned above with brief explanation of each of the attributes.
- ☆ Each nomination entry should accompany a mandatory "Statement of Intent" stating the reasons for nominating the entry to CSI - Nihilent e-Governance Awards 2010-11. This should not be of more than half a page.
- ☆ Applicants have to register their particulars before submitting their nominations.
- ☆ Registration & Nominations window open from 1st May 2011 and closes on 22nd Aug 2011.

## CSI-Nihilent e-Governance Awards 2010-11

The Computer Society of India has instituted a series of awards for recognizing the contributions made in the field of e-Governance in the country. These awards have been sponsored by Nihilent Technologies. The awards are given for recognizing the efforts made in e-Governance area at the State, Department, District and Project level.

### AWARD CATEGORIES

Nominations for the year 2010-11 Awards are being invited for the following four categories



**Award of Excellence - State Category:** Nominations will be judged based on their overall performance in e-Governance initiatives during the year 2010-11, especially with respect to policies, infrastructure, capacity building, projects, etc. across the State.



**Award of Excellence - Department Category:** Nominations from Central and State Government Departments or Central/State undertakings, will be judged based on those who have demonstrated excellence in the area of e-Governance during the year 2010-11.



**Awards of Excellence - District Category:** For Outstanding efforts demonstrating excellence in e-Governance during the year 2010-11 at the District level.



**Award of Excellence - Project Category:** Nominations of Projects that have been implemented or significantly enhanced during the year 2010-11 and have delivered benefits to its stakeholders will be judged in three sub-categories, namely G2C, G2B, and G2G/G2E.

Note: Depending on the number and quality of entries, nominations may be considered for Winner/Appreciation Award under each of above category. The decision of the Selection Committee will be final.
